

ORDINANCE NO. 6463-08

AN ORDINANCE TO AMEND AND REORDAIN CHAPTER 26, MOTOR VEHICLES AND TRAFFIC, OF THE CODE OF THE CITY OF NEWPORT NEWS, VIRGINIA, ARTICLE V., PERMIT FOR OPERATION OF OVERSIZE OR OVERWEIGHT VEHICLES OR MOVING HOUSES.

WHEREAS, the Council of the City of Newport News, Virginia, (the "Council") is authorized to issue permits for use of City street by Oversize and Overweight vehicles pursuant to Virginia Code § 46.2-1139; and

WHEREAS, the Council wishes to recodify Article V of Chapter 26 to bring same in line with the City's Moving and Hauling Policy;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Newport News, Virginia:

1. That it desires to, and hereby does, recodify Chapter 26, Motor Vehicles and Traffic, Article V, Permit for Operation of Oversize or Overweight Vehicles or Moving Houses, to provide as follows:

CHAPTER 26

MOTOR VEHICLES AND TRAFFIC

ARTICLE V. PERMIT FOR OPERATION OF OVERSIZE OR OVERWEIGHT VEHICLES OR MOVING HOUSES

Sec. 26-89. General authority to issue.

The director of engineering or his designee may issue permits, conditioned as deemed necessary or advisable, permitting the operation of vehicles, or combinations thereof, the width, height, length or weight of which exceed that permitted by the state law adopted by section 26-8, if such operation will not damage any infrastructure, render the streets dangerous or otherwise unduly impair the free flow of traffic thereon. The issuance of permits shall be in accordance with the City's Moving and Hauling Policy, a copy of which is incorporated herein by reference. Permits issued in accordance with this section shall be designated as Single Trip, General Blanket Permit, or Restricted Blanket Permit, as defined in the City's Moving and Hauling Policy, attached herewith and incorporated herein by reference.

Sec. 26-90. Blanket permits.

General Blanket and Restricted Blanket permits may be issued under section 26-89 to any individual, business entity, government agency or a utility company for a specific vehicle owned or operated by it, subject to the requirements of Sec. 26-93 and the City's Moving and Hauling Policy.

Sec. 26-91. Effect of issuance of state permit for operation over primary routes.

A person shall be deemed to have obtained a permit from the director of engineering for the operation of an overweight, overwidth, overlength, overheight or unlicensed vehicle if such person is operating such vehicle pursuant to a permit issued by an appropriate agency or entity of the Commonwealth of Virginia over primary routes through the City. A permit shall be required and may be issued for the movement of overweight, overwidth, overlength, overheight or unlicensed vehicles over all other streets in the city, whether or not the permittee has a permit from the state highway and transportation commission.

Sec. 26-92. Permit required for transport of Super Loads

No person shall move on, transport over, carry along or convey upon any street of the city any Super Load , as that term is defined by the City's Moving and Hauling Policy, or anything so heavy as to require the use of structural deck plating, skids or rollers for the transporting thereof, unless such person shall have secured a permit to do so from the director of engineering or his designee, and has complied with Sec. 26-93 and the City's Moving and Hauling Policy.

Sec. 26-93. Applicant's insurance or bond.

Before issuing any permit pursuant to this article, the director of engineering or his designee shall require the applicant to file evidence of insurance or a bond, in the form of a cash bond, corporate surety bond, or irrevocable letter of credit, adequate to protect the City from any liability or damage to streets which may arise from the permitted operation and which in no instance shall be less than one million dollars (\$1,000,000.00) per occurrence.

Sec. 26-94. Permit fees and charges.

A permit fee of seventy five (\$75.00) shall be paid to the City before any Single Move Permit (excluding Super Loads) shall be issued under this article; provided, however, that (i) the fee for each General Blanket Permit shall be two hundred dollars (\$200.00) for the first vehicle owned, leased or controlled by a person or business entity and fifty dollars for each additional vehicle owned, leased or controlled by such person or entity or (ii) the fee per vehicle for each

Restricted Blanket Permit issued under section 26-90 shall be two hundred dollars (\$200.00). A permit fee of one hundred and fifty dollars (\$150.00) shall be paid to the City before any Super Load permit for a single move, shall be issued under this article. No blanket permits are available for Super Loads.

Sec. 26-95. Agreement to comply with permit and the City's Moving and Hauling Policy and to repair damages caused by oversized or overweight vehicles.

a. Acceptance of a permit by the applicant requires that he/she certify that the vehicle load can and will be moved in strict compliance with the terms set forth in the permit and in the City's Moving and Hauling Policy, that the operator of the vehicle is properly licensed to operate the vehicle on public highways and that all information submitted to secure the permit is accurate. No person, owner, representative, agent or employee of the permittee shall knowingly allow anyone to violate the regulations or restrictions set forth in the permit and the City's Moving and Hauling Policy.

b. By the acceptance of a permit under this article for the operation of an oversized or overweight vehicle, or by the operation of such a vehicle when no permit from the City is required by virtue of the provisions of section 26-91, a person agrees to restore or repair any damage caused by the vehicle to any street or appurtenances thereto.

Sec. 26-96. Conditions of permit for overlength vehicles.

Unless otherwise specified in the permit, every permit issued under this article for the operation of an overlength vehicle shall be deemed to include the following:

a. The permittee agrees to give adequate warning to the traveling public of the overlength vehicle and further agrees that the maximum overhang shall not exceed one-third (1/3) of the overall length of the load.

b. The permittee shall not permit the overlength load or any part thereof to drag upon the roadway, regardless of whether overhang has been permitted.

Secs. 26-97--26-106. Reserved.

2. That Council further adopts the City's Moving and Hauling Policy, a copy of which is attached to this Ordinance, and further determines that this Moving and Hauling Policy may be amended from time to time by the director of engineering in accordance with federal, state and local law.

3. That this ordinance shall be in effect on and after the date of its adoption, February 26, 2008.

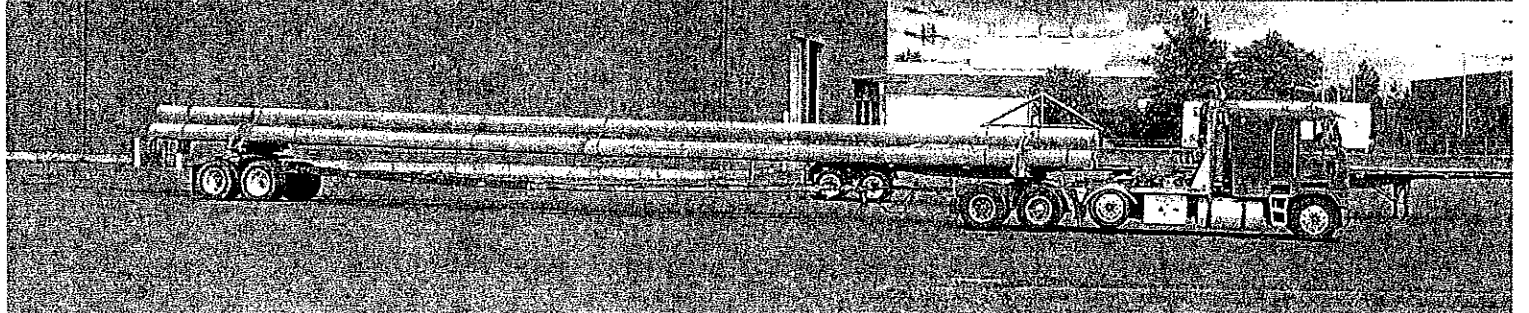
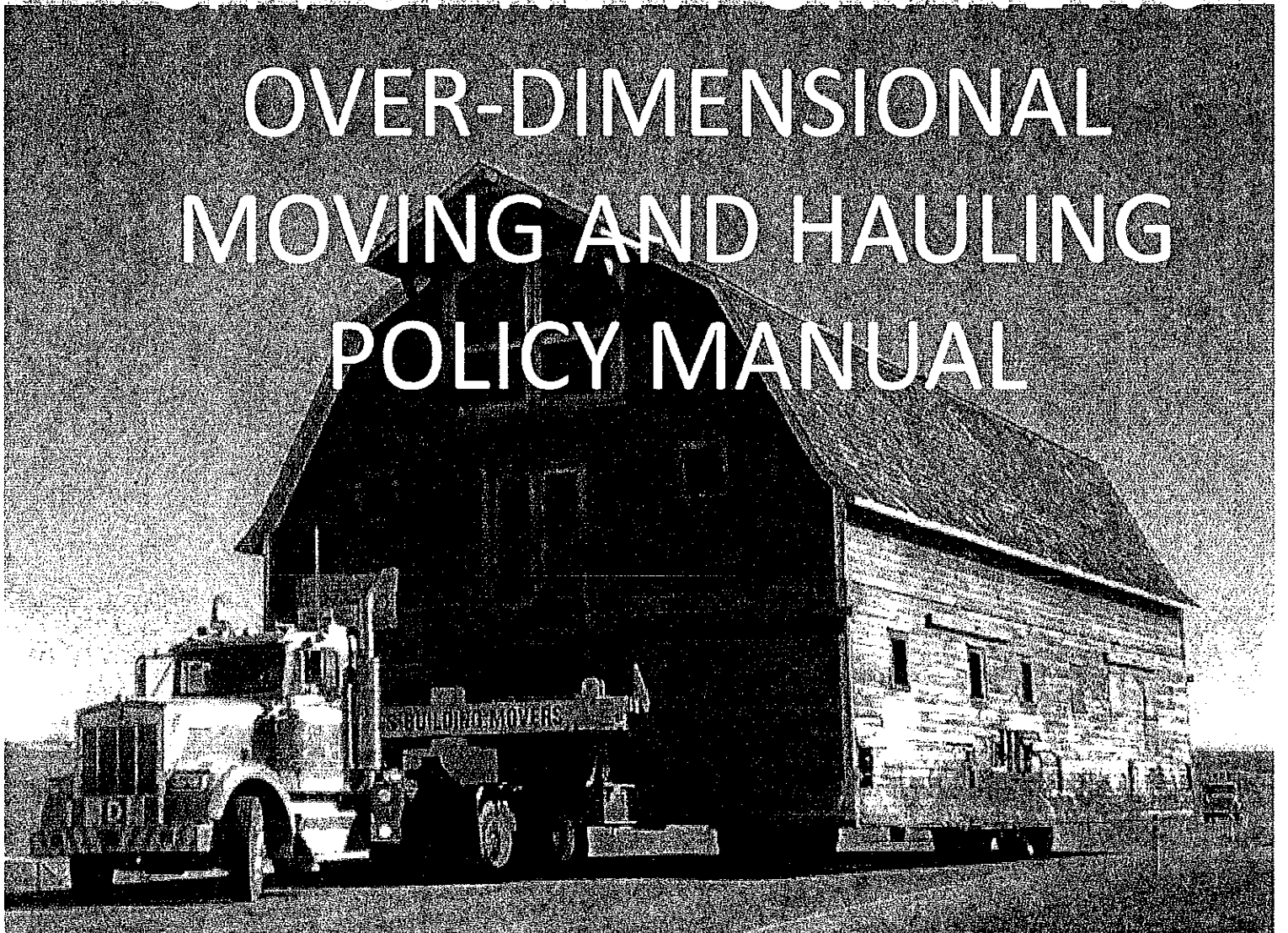

PART I
GENERAL PROVISIONS

SECTION 1 - Definitions

"Applicant" is one who makes a request for a moving and hauling permit.

"Approved Routes" are those travel routes within the City of Newport News most suitable for over-dimensional/ overweight vehicles as determined by the City's Department of Engineering.

"General Blanket Permit" means the permit is valid for more than one move with approved routing throughout the City.

"B-train Assembly" means a rigid frame extension attached to the rear frame or a first semi-trailer which allows for a fifth wheel connection point for the second semi-trailer.

"Certified Escort Driver" is the driver of an Escort Vehicle, who must have a valid Virginia Driver's license or a valid license in the state or jurisdiction in which he or she is a resident, comply with the permit policies and regulations and all city and state traffic laws and must have successfully completed the Virginia Escort Driver Certification Program.

"DMV" is the Virginia Department of Motor Vehicles. Information on permits for interstate travel can be obtained through the DMV Hauling Permit Office at (804) 786-3495.

"Emergency" An emergency is defined as a calamity, existing or imminent, caused by fire, flood, riot, windstorm, explosion or act of God, which requires immediate remedial action to protect life or property. All emergency move notification shall also be called in to the Engineering Department's Permit Office at (757) 926-8611. After normal office hours call City of Newport News Police Dispatch at (757) 247-2500.

"Engineering Analysis" is evaluation by independent professional engineering services firms to assess the impacts on infrastructure, along a restricted route, from the passage of overweight vehicles.

"Escort Vehicle" is a companion vehicle, properly marked and equipped, whose support function is to assure safe passage. Refer to Part V, Section 14 for escort vehicle requirements

"Extremely over-dimensional and/or overweight movements" (See "Super Loads")

"Non-divisible load" is a vehicle configuration exceeding applicable size or weight limits which, if separated into smaller loads, would:

1. Compromise the intended use of the vehicle, i.e., make it unable to

perform the function for which it was intended: or

2. destroy the value of the load or vehicle, i.e., make it unusable for its intended purpose; or

3. require more than eight work hours to dismantle using appropriate equipment (this does not include reassembly). The applicant for a non-divisible load permit has the burden of proof as to the number of work hours required to dismantle the load.

"Overhang" is that portion of a vehicle/load that extends horizontally beyond the frame of the vehicle either to the front, back or side (or sides).

"Permitting Authority" is the Department of Engineering of the City of Newport News, which is the responsible authority for the issuance of over dimensional/overweight moving and hauling permits within its jurisdiction.

"Permits Office" is the Engineering representative responsible for issuing moving and hauling permits.

"Permittee" is one who has been granted a permit.

"Posted Roads" are highways or bridges which have signage restricting travel to limited size and/or weight vehicle loads due to infrastructure design constraints, age or condition.

"Primary Routes" are highways within the city limits directly maintained by the Virginia Department of Transportation.

"Right-of-way" is the land, property, or interest therein, usually in a strip, acquired for, used as or devoted to a public street or road.

"Restricted Blanket Permit" means the permit is valid for more than one move on condition of use on limited approved routing with consideration of bridge loading requirements.

"Routing" are authorized roadways of travel.

"Semi-trailer" is a vehicle of the trailer type so designed and used in conjunction with a motor vehicle that some part of its own weight and that of its own load rest on or is carried by another vehicle.

"Single Trip Permits" are move permits between two pre-determined start and end points. Single trip permits may be restricted moves at the discretion of the permitting authority.

"Stinger-steered automobile and water-craft transporters" is an automobile or water-craft transporter configured as a semi-trailer combination wherein the fifth wheel is located on a drop frame behind the rearmost axle of the power unit.

"Sunrise / Sunset" are the official times listed in news publications (i.e. Local Newspapers, Airports, News Broadcast, National Weather Service, NOAA) for solar light conditions which define a day.

"Super Load" is a load configuration that exceeds one or more of the parameters listed below and therefore shall require a super load permit:

Height: 15 Feet
Width: 15 Feet
Length: 150 Feet
Single Axle Weight: 24,000 Pounds 'Tandem
Axle Weight: 44,000 Pounds
Gross Weight: 130,000 Pounds

"Truck Tractor" is a motor vehicle designed and used primarily for towing other vehicles and not constructed as to carry a load other than a part of the load and weight of the vehicle attached to that vehicle.

"Trailer" is a vehicle without motive power designed for carrying a load wholly on its own structure and for being towed by a motor vehicle, including mobile homes.

"Truck" is a motor vehicle designed to transport a load on its own structure independent of any other vehicle and having a registered gross weight in excess of 7,500 pounds.

"Vehicle configuration" is the height, weight, width and length of a vehicle to include vehicle axle spacing and tire width.

SECTION 2- General

- A. The Code of Virginia sets forth limitations of weight, width, height and length of objects and vehicles which may be moved upon state highways and also empowers the Commonwealth Transportation Board to issue oversize or Overweight permits for vehicles traveling over Virginia's highways with loads that, when reduced to their smallest dimensions, exceed maximum legal limits. See, Virginia Code § 46.2-1123 thru 1127.
- B. The intent of establishing statutory limitations is to protect the traveling public from hazard and unnecessary inconvenience, and to preserve the capacity and structural integrity of highways and bridges.
- C. The Virginia Department of Motor Vehicles has jurisdiction on those roads maintained by the Virginia Department of Transportation. The City of Newport News has jurisdiction on all public highways within and maintained by the City, except for Interstate 64 and Interstate 664. See, Virginia Code § 46.2-1138.1 thru 1139.
- D. The policy of the City of Newport News is to give primary consideration to safety, comfort, convenience and economic interest of the general public and the protection of local highways.

SECTION 3 - Authority: Permits

- A. The City of Newport News shall require a copy of any valid DMV issued permit and or City issued permit to be present in the vehicle when moving between the Interstate System and adjacent county/state controlled highways and upon locally controlled streets in Newport News.
- B. Application for City of Newport News permits shall be made to the Department of Engineering, Permits Office – 8th Floor City Hall, 2400 Washington Avenue, Newport News, Virginia 23607, (757) 926-8611 [Facsimile 757-926-8300].
- C. Permits may be denied, revoked or declared non-existent as stated in Part IX, Section 22 & 23.
- D. Permits issued by this Authority are non-transferable.
- E. Permits may be obtained in the following ways:

SECTION 4 - Statutory Limitations - When Permitting Required

If the dimensions of the vehicle combination or non-divisible load, or both, exceed one or more of the following statutory limitations listed below, a permit is required.

Single Axle Weight: _____ 20,000 pounds or 650 pounds per inch of tire (width) in contact with the surface of the highway. ¹

Tandem Axle Weight: _____ 34,000 pounds (more than forty inches (40") but not more than ninety-six inches (96") between axle centers). ²

Gross Weight: _____ See Section 5 - Legal weight allowed based on axle spacing. ³

Width: _____ Eight feet six inches (8'6") excluding mirrors. Safety devices not to exceed 3 inches on each side

Height: _____ Thirteen feet six inches (13'6") ⁴

Length:

Truck: Forty feet (40') excluding load ⁵

Semitrailer: Forty-eight feet (48')

Twin trailers: Twenty-eight feet six inches (28'6")

Tractor Semitrailer Combination: Sixty-five feet (65') including load

Combination of a towing vehicle

and any manufactured housing: Sixty feet (60') including load and coupling

Front Overhang: _____ Exceeding three feet (3') ⁶

SECTION 5 - Legal Weight Allowed Based on Axle Spacing

Legal weight in pounds for any group of two or more consecutive axles. A hauling permit is required when a vehicle configuration exceeds the weight limitations according to axle spacing. "L" is defined as the distance in feet between the extremes of any group of two or more consecutive axles. (As provided by statute Virginia Code Section § 46.2-1026)

SECTION 6 - Maximum Weight Allowed by Permit Based on Axle Spacing 24 VAC 30-111-60

Maximum weight in pounds according to vehicle axle spacing allowed by permit shall not exceed the following without requiring an engineering analysis:

Maximum axle weights -

Single Axle Weight: 24,000 lbs. (or 850 pounds per inch, width of tire measured in contact with the surface of the road). See axle weight requirements for blanket permit vehicles where authorization is requested for crossing a bridge structure.

- Tandem Axle Weight: Refer to axle spacing chart on next page.
24 VAC 30-111-70
- Tri-Axle and Quad-Axle Groups: Refer to axle spacing chart on next page.
24 VAC 30-111-70

Note: Vehicles exceeding the axle weight and gross weight limits of this section shall be considered on a case by case basis by the Department of Engineering, Permits Office. A permit will not be issued if the load can be reasonably reduced to legal limitations of size and weight as described in Section 5. Hauling more than one item at a time, gross weight and axle weights shall be in accordance with Section 5. Load items shall not be loaded side by side to create an over width condition; end to end to create an over length condition; or stacked to create an over height condition. Field verification by the permitting authority may be required to determine whether an item can be reasonably reduced.

All vehicle configurations shall be reduced to the smallest dimensions possible and those exceeding the specifications identified in this chart will require an engineering review before a permit can be issued.

Part III

Descriptions, Requirements and Limitations of Permits Available

SECTION 7 - Requirements for application

Application for moving and hauling permits must be made on the appropriate form. There is an application form at the back of this manual, which may be reproduced and used. Application forms may also be obtained by calling the Permits Office at (757) 926-8611 or online at www.nngov.com/engineering/permitsoffice. Completed applications may be faxed to (757) 926-8300. The party requesting the permit must provide as a minimum the following information:

- A. Name, phone number, fax number and signature of the applicant/permit agency requesting permit;
- B. Company name, phone number, fax number and address of mover (if different from above);
- C. Description of equipment and/or load to be moved;
- D. Overall dimensions, gross weight, and spacing of axles and tire width;
- E. A Vertical/Horizontal Clearance Certification Statement;
- F. Truck and trailer license numbers and State of registration;
- G. Origin and destination of movement within City of Newport News;
- H. Proposed roadway routes over which movement is requested;
- I. Overweight vehicles must include maximum weight, weight distribution, number of axles and distance between each axle on vehicle/combination and tire width;
- J. Copy of Virginia Department of Motor Vehicles moving and hauling permit for vehicle/load;
- K. Valid certificate of automobile liability insurance with limits no less than \$1,000,000; and
- L. A surety bond may be required for extremely over-dimensional and/or overweight movements (See Super Loads).

SECTION 8 - Single Trip Permits

As provided for by Virginia Code Section 46.2-1139, a Permit is required for vehicles with dimensions exceeding the Height, Width, Length or Weight specified in Section 4.

A. How permits are reviewed and issued

All vehicles, which exceed the Height, Width, Length or Weight specified in Section 4 and do not qualify for other "blanket" permits, shall apply for a single trip permit. Each move is individually reviewed to allow a two way vehicle trip between two (2) specific points. Each permit issued will be valid for a maximum of 72 consecutive hours (subject to conditions of paragraph B. below) and the cost of the permit is \$75. If requested at the time of application, the permit may allow for a return trip within 7 days from its effective start date and time at no extra charge. The applicant shall allow for a review time of no less than three (3) working days from date of receipt of application.

1. Permit criterion is based primarily on the weight and dimensions of the vehicle and load. The maximum dimensions for which a single trip permit can be issued are as follows:
 - a. Gross weight – up to 130,000 lbs
 - b. Height – up to fifteen feet (15')
 - c. Width – up to fifteen feet (15')
 - d. Length – up to one hundred and fifty feet (150')

B. When load may be moved

The permit will specify days and times of travel. Extremely over-dimensional/overweight vehicle trip moves will usually be scheduled to move during weekday early mornings. Requests for movement at any other time shall be stated on the application and is subject to approval by the Permitting Authority.

C. When City crews may be required

City crews may be required to escort a move when:

1. City infrastructure must be altered in any way (e.g. when signs or traffic signals are moved); and/or
2. Police escort may be required for public safety as determined by the Permitting Authority.

All costs associated with field assistance by city crews present during the move are chargeable to the applicant and the estimated cost is due at the time the application is approved. If the actual cost significantly exceeds the estimate, then the applicant will be billed for the additional cost.

D. When a surety may be required

Surety may be required upon evaluation of extremely over-dimensional or overweight movements. The amount of the surety is determined based on: the estimated cost of restoring the City's infrastructure should damage occur during the move, and all costs of City crew and equipment required for the move.

A letter of credit, cash or cashier's check by either the mover or the owner of the item to be moved, or a corporate surety bond issued by a company approved by the Virginia Bureau of Insurance must be posted to meet surety requirements. Sureties must be posted with the Permits Office prior to the issuance of a permit. The permittee must notify the Permits Office upon completion of the move to request a release of surety. Any damages or unpaid costs not covered by the pre-move estimate must be addressed before the surety will be released by the Permitting Authority.

E. Responsibility

Permittee is responsible for checking all horizontal and vertical clearances along each proposed route of travel to ensure that proper clearances exist. For over-height or over-width movements, a Vertical/Horizontal Clearance certification statement must be provided with the application.

(See Form No. PO. 1)

Travel shall not commence without proper clearances along all proposed routes of travel. Over-height vehicles shall be equipped with an over-height pole (hot pole) extended to a minimum of 3" higher than the permitted height of the vehicle/load (See Section 14H).

F. Coordination with Utility Companies:

Permittee is responsible for coordinating with utility companies and public agencies where conflicts with utility infrastructure (e.g. overhead lines) are anticipated. The Permitting Authority will require written verification from the various utility owners affected by the move stating that they have been notified of the move and will have crews available to assist the mover if necessary.

G. Approved Routes as determined by the Permitting Authority are those travel

routes authorized by the City of Newport News Department of Engineering. If a bridge or structure must be crossed and the vehicle/load exceeds the limits established by the Weight/Axle Spacing Chart of Section 6, a bridge analysis will be required.

- H. On two lane non-divided roadways, moves exceeding the travel lane width may require a police escort, in addition to the required civilian escort(s) at the discretion of the Department of Engineering.

SECTION 9 - General Blanket Permits

- A. How General Blanket permits are issued.

1. General Blanket Permits may be issued for frequent moves of an on-going nature along one or more routes when the General Blanket Permit criteria are met. General Blanket Permits will be issued for up to twelve months, the cost is \$200 each and review time is up to five (5) business days. All blanket permits will be evaluated prior to renewal.
2. Permit criterion is based on the weight and dimensions of the vehicle and load. The maximum Non-divisible weight or dimensions for which a General Blanket Permit can be issued are as follows:
 - a. Gross weight – up to 115,000 lbs with 7 axles*
 - b. Height – up to fourteen feet (14')
 - c. Width – up to twelve feet (12'); fourteen feet (14') for mobile homes
 - d. Length – up to eighty-five feet (85'); one hundred feet (100') for mobile homes

A violation of any one of the above criterion by any vehicle/load or combination will require permitting. All General Blanket Permit requests for overweight vehicles must adhere to the Weights and Axle Chart in Section 6. Additionally said vehicle loading must be reduced to a "non-divisible load" regardless of the maximum weight allowed by the Axle Chart in Section 6.

- B. Separate General Blanket Permits for each truck or truck tractor hereafter in part B and C as "vehicle":

Each vehicle making a move under a blanket permit will be required to have an original permit, assigned only to the one vehicle designated on the permit, in the vehicle at the time of the move. Permits may not be used for vehicles other than the one specified on the permit.

C. Vehicles will be defined on General Blanket Permits:

The vehicle assigned to the permit, the specific dimensions, days and times of travel, escort requirements and notification policies are specified and stated on the permit.

D. Applicants having multiple vehicles requiring General Blanket Permits may apply for permits for said multiple vehicles with one application for an additional fee of \$50.00 per additional vehicle. This "fleet permit allowance" will be provided for General Blanket qualifying vehicles as follows:

1. The permit fee for the first applicant vehicle will be \$200.00
2. Every vehicle permitted thereafter applied for under the same application will be \$50.00.
3. Qualifying vehicles must be owned/operated by the same business entity.
4. Vehicles must be operated/garaged/maintained from the same jurisdiction
5. The application for this "Fleet Permit Allowance" must be submitted at the same date and time.
6. Specific identifying vehicle information must be provided for each vehicle/combination permitted.
7. Permits are non transferable and vehicles may not be added after the permit has been issued.

SECTION 10 - Restricted Blanket Permits

A Restricted Blanket Permit may be issued when the vehicle's configuration does not warrant unrestricted travel throughout the City of Newport News and therefore should not be granted a general blanket permit. Restricted Blanket Permits can be issued for a period of three (3) months. The permit fee is \$200.00 each. Review time is up to five (5) business days. Additional time may be required depending on the number of vehicles or other factors specific to the permit application.

- A. Mobile cranes, as reduced to their minimum Non-divisible load gross vehicle weight, up to 130,000 pounds and exceeding the "maximum weight/axle spacing" (section 6) will be considered under this category.
- B. Restricted Blanket Permit criterion is based on the Non-divisible weight and dimensions of the vehicle and load. The maximum Non-divisible weight or dimensions for which a restricted Blanket permit can be issued are as follows:
 - a. Gross weight — more than 115,000 lbs but less than 130,000 lbs
 - b. Height — more than fourteen feet but less than fifteen feet (15')

- c. Width — more than fourteen feet (14') but less than fifteen feet (15')
- d. Length — more that eighty feet (80') but less than one hundred and fifty feet (150')

A violation of any one of the above criterion by any vehicle/load or combination will require Restricted Blanket Permitting. Additionally said vehicle loading must be reduced to a "non-divisible load" regardless of the maximum weight allowed.

C. Separate Restricted Blanket Permit for each vehicle:

Each vehicle making a move under a Restricted Blanket Permit will be required to have an original permit, assigned only to the one vehicle designated on the permit, in the vehicle at the time of the move. Permits are not transferable and may not be used for vehicles other than the one specified on the permit.

D. Vehicles will be defined on Restricted Blanket Permit:

The vehicle assigned to the permit, the specific dimensions, days and times of travel, escort requirements and notification policies shall be stated on the permit.

Restricted Blanket Permits shall have designated routes of travel through the City. No bridge structures shall be crossed without acceptable Engineering Analysis.

SECTION 11 - Super Load Permits

- A. A Vertical/Horizontal Clearance Certification Statement must be provided with the application. (See Form No. P01) Each move is individually reviewed. Review time is up to seven (7) days; however additional review time may be required depending on the complexity of the move and other factors specific to the permit application.
- B. Permittee is responsible for coordinating with the City of Newport News Traffic Operations Division (telephone 757-269-2450) where overhead signal or communications cable conflicts are expected. The Permits Office will require written verification from the various utility companies affected by the move stating that they have been notified of the move and will have crews available to assist the mover if necessary.

All costs associated with field assistance by City crews present during the move are chargeable to the applicant and the estimated cost is due at the time the application is approved. If the actual cost significantly exceeds the

estimate, then the applicant will be billed for the additional cost.

- C. Permitted moves will be restricted to off peak hours. Request for movement at any other time shall be stated on application and are subject to approval by the Permitting Authority.
- D. Mover shall comply with all sign, escort, and safety requirements as listed in Part V – Sections 13, 14 and 15.
 - 1. For extremely over-dimensional or overweight movements, a Super Load Permit shall be required. The applicant shall allow for a review time of up to 30 days¹ and the cost is \$150.00. Each Super Load Permit will be valid for 1 day unless otherwise indicated on the approved permit. Additional time for the move will be as specified on the application and/or as approved by the Permitting Authority.
 - 2. Permit criterion is based on the Non-Divisible weight and dimensions of the vehicle and load. The minimum Non-Divisible weight or dimensions for which a super load permit can be issued are as follows:
 - a. Gross weight – greater than 130,000 lbs
 - b. Height – greater than fifteen feet (15')
 - c. Width – greater than fifteen feet (15')
 - d. Length – greater than one hundred and fifty feet (150')
 - 3. For Super Loads, field verification may be required to determine if the load item can be reasonably reduced. Field verification may also be required to determine that a load is in accordance with the approved permit prior to its movement within the City of Newport News. An engineering analysis of the route, by a licensed engineer, shall be provided by the applicant where requested for extreme weights.

Part IV
Travel
Restrictions/Regulations

SECTION 12 - Travel Restrictions; Holiday Travel; Days and Times of Travel-

A. Holidays

Permitted vehicle configurations are allowed to travel on all holidays except the following State observed holidays:

New Year's Day
Memorial Day
Independence Day
Labor Day
Thanksgiving Day
Christmas Day

Note: On the holidays mentioned above, permits will not be valid from noon of the preceding weekday through the holiday. If the observed holiday falls on a Monday the permit will not be valid from noon on the preceding Friday through Monday.

B. Times of Travel

1. Normal time of travel for permitted load is in conformance with the City of Newport News Work Hour Restrictions for lane closures and roadway operations. Unless otherwise specified, the restricted time for haul shall be:
 - Monday through Friday 8:00 a.m. to 3:00 p.m. and
 - Monday through Friday 7:00 p.m. to 6:00 a.m.
 - Saturday – unrestricted
 - Sunday – unrestricted

❖ Super Load vehicles shall be restricted to off peak hours.
2. The Permitting Authority shall have the authority to route vehicles outside the normal hours of travel or restrict times of travel or movement during normal hours of travel if it is determined necessary, giving primary consideration to the safety and well being of the traveling public.
3. When road conditions, visibility or unfavorable weather conditions make traveling hazardous to the operator or the traveling public, permitted vehicles are not authorized to operate, unless responding to an emergency. Vehicles, which are underway when inclement weather occurs, shall exit the road at the first available safe location and park in a safe place until the weather clears or until road conditions improve to allow safe travel conditions. Law enforcement judgment shall prevail in all circumstances.

C. General Travel Restrictions

Unless otherwise specified within the permit:

1. Traffic shall not be detained for any reason without an approved traffic control plan or police escort. The driver of the permitted vehicle will make every effort not to impede or inconvenience other vehicles.
2. Over-dimensional loads shall not travel in convoy.
3. No bridge railings are to be removed or adjusted, roadway structures altered, traffic control devices or signs modified or removed to allow passage without the written permission from the Permitting Authority.
4. When road machinery is operating OUTSIDE the limits of a construction project, either towed or under its own power, it is subject to the legal size and weight limits. Hauling permits ARE required from the Permitting Authority for these moves.
5. When operating within the limits of their construction project, road machinery does not need a moving or hauling permit providing that the machinery/equipment is under that specific project contract. When road machinery is operating outside the limits of the construction project either towed, hauled, moved or under its own power, it is subject to the legal size and weight limits of Section 4. However, if such machinery/equipment is operated on public highways it shall be in compliance with state (§ 46.2-1149) and local ordinances.
6. Each permit shall specify the route(s) to be traveled. All permitted vehicles will be routed over the safest and most desirable roadways, in the judgment of the issuing authority, even though it may mean the distance to be traveled will be farther.
7. No vehicle shall be operated or driven across any bridge or culvert posted with regulatory signage indicating a weight limit if the gross weight of such vehicle is greater than such posted limit. The Permitting Authority may impose temporary weight restrictions for reasons of deterioration or weather conditions. These restricted weights shall be noted on the permit and shall have the same effect as if posted. No vehicles, loads or machinery shall travel across any such area of reduced weight restrictions.
8. Overhang - General
 - a. Any side overhang that exceeds three feet (3') from the edge of the bed of the hauling vehicle shall be considered a wide load requiring submission of a diagram showing placement of the load on the hauling vehicle. Loads with overhangs exceeding three feet (3') will require certified front and rear escorts.

- b. Front overhang shall not exceed three feet (3')
- c. Rear overhang shall not exceed one third of the length of the load, two thirds of which must rest upon the truck or trailer. Whenever the load on any vehicle extends more than four feet (4') beyond the rear of the bed or body thereof, there shall be displayed at the end of the load, in such a position as to be clearly visible at all times from the rear of the load:
 - A red flag, not less than eighteen inches (18"), both in length and width;
 - a certified rear escort shall be required; and
 - between sunset and sunrise there shall be displayed at the end of the load a steady burning red light plainly visible in clear weather at least five hundred feet (500') to the sides and rear of the vehicle (§46.2-1121). This is in addition to the flashing amber light requirement set forth in Part V - Section 15.D.
- d. Under no circumstances shall an over length load be allowed to come in contact with the roadway.

9. For night moves see Part V - Section 15.B.

Part V
Escort Services and
Other Safety Regulations

SECTION 13 - Escort Certification

Certification as an escort driver is mandatory for all drivers, regardless of their residence, who escort over-dimensional loads over the roadways of the City of Newport News. Escort drivers must carry proof of current certification while performing a move.

The Virginia Escort Driver Certification Program consists of a written knowledge test which shall be successfully completed before a certificate is issued. Applicants residing outside Virginia can arrange to take the test in their state of residence. For more information concerning Escort Certification in Virginia, call the Virginia Department of Motor Vehicles at (804)786-3495.

SECTION 14 - Escort Vehicle Requirements

- A. Depending on the route being traveled,
1. Front and or rear escorts shall be required for vehicles having one or more of the following configurations:
 - a. With a width in excess of five feet three inches (5'3"), as measured from the center of the vehicle to the widest part of the transport vehicle or load;
 - b. exceeding fourteen feet (14') in height;
 - c. eighty-five feet (85') in length;
 - d. when results of an engineering analysis show that escorts are needed to provide traffic control for protection of the city's infrastructure (i.e. Bridge traffic signals, etc...)
 2. Rear escorts will be required for any permitted vehicle with a rear overhang exceeding four feet (4').
- B. All escort vehicles shall:
1. have 180 degrees of forward visibility and a direct line of sight to the rear through a rear window.
 2. not exceed 30 feet in overall length or be over-dimensional in weight, height or width.
 3. not be a combination vehicle.
 4. not carry any materials requiring it to display HAZMAT placards.
 5. be in safe operating condition.

- C. All escort vehicles shall be equipped with a working phone or two-way radio and maintain communication with the permitted vehicle driver and any other escort vehicles involved.
- D. Escort vehicle(s) shall maintain a reasonable and prudent distance in regards to roadway location, speed limit and traffic volumes, in front of or behind permitted vehicle configuration to warn approaching motorists of the oversize or overweight vehicle configuration.
- E. Escort vehicles shall have signs, descriptive of the load it is escorting, i.e., "Wide Load" or "Oversize Load" or "Over-dimensional Load" or "Overweight Load" displayed on the vehicle to be visible to approaching motorist in day or night. All signs shall have black lettering on a yellow background, mounted at least eighteen inches (18") above the roadway surface. The lettering shall be an eight inch (8") minimum height with a one and one-half inch (1-1/2") minimum brush stroke width, and a minimum one inch (1") border all around. Signs shall be clean, legible and mounted securely.
- F. At least one amber high-intensity flashing, blinking or alternating light shall be located on top of the escort vehicle. The light shall be visible for a distance of five hundred feet (500') or greater and from 360 degrees. All lighting shall conform to § 46.2-1026, Virginia Code.
- G. The escort vehicle's headlights and any other steady burning exterior lights shall be turned on while escorting an overweight or oversize permitted vehicle. Hazard 4-way flashers shall not be used when vehicular speed exceeds 35 mph.
- H. A front escort vehicle equipped with a hot-pole is required when the overall height of a vehicle configuration exceeds 14'. The hot-pole shall extend three inches (3") above the specified overall height of the permitted load.

SECTION 15 - Safety Requirements

- A. When movements within the city will stop traffic for any reason an approved traffic control plan or police escort is required.
- B. When an over-dimensional movement is routed upon any highway which is too narrow for two-way travel at all points, the front escort vehicle or a flagman shall advance to a point where two-way traffic can be maintained, stopping on-coming traffic at that location. When the load reaches the location where traffic is stopped, the over-dimensional unit shall halt and allow traffic to clear from both directions, the front escort vehicle or flagman shall then advance to the next part for stopping traffic.
- C. Flags - Red flags or any highly visible fluorescent colored flags shall be displayed at each of the four corners of any vehicle configuration that is over-width or over-length. Flags shall be placed at the extremities of the width or length.

Flags must be eighteen inches (18") square and in good condition. Flags are not required when the vehicle is only over-height or overweight.

Exception for Night Moves: For any moves sunset to sunrise, amber lights are required on the extremities in addition to the flags.

C. Flagman - When required to post a flagman to warn and direct approaching traffic, each flagman shall possess a current certification from an approved Virginia Department of Transportation program or an equivalent program of another state to perform this task. The burden shall be on the person moving the load to demonstrate equivalency of the programs. Flagmen shall wear a red or any highly visible fluorescent colored jacket or vest and be equipped with paddles reading "STOP" in white letters with red background. The paddles shall be a minimum of twenty-four inches (24") in diameter and mounted on a pole measuring six feet (6'). Flagmen shall not be less than eighteen (18) years of age and capable of carrying out flagging responsibilities.

D. Amber Flashing Lights - Over dimensional vehicles and loads. One amber flashing light shall be located on top of the towing vehicle plus one amber flashing light shall be located on upper rear of the vehicle or load being hauled, towed or self-propelled. Lights shall be visible for a distance of five hundred feet (500') or greater and shall be of the type approved under Virginia Code §46.2-1026.

E. Signs

1. All permitted loads or vehicles being moved on City roadways exceeding eight feet six inches (8'6") width, sixty-five feet (65') in length or vehicle with a load more than a six inches (6") over hang, shall display appropriate warning signs in accordance with the Virginia Department of Transportation Escort Driver's Manual.
2. Signs shall be posted front and rear and shall read "WIDE LOAD" or "OVERSIZE LOAD." The "WIDE LOAD" sign shall be used when overall width exceeds eight feet six inches (8'6"). The "OVERSIZE LOAD" sign shall be used for over length and other oversize features. More definitive signs such as "WIDE LOAD" or "LONG LOAD" may be substituted for the "OVERSIZE LOAD" sign when appropriate. The "LONG LOAD" sign shall have preference when length exceeds one hundred feet (100') and other oversize features exist.

All signs shall have black lettering on a yellow background, mounted at least eighteen inches (18") above the roadway surface. The lettering shall be an eight inch (8") minimum height with a one and one-half inch (1-1/2") minimum brush stroke width, and a minimum one inch (1") border all around. Signs shall be clean, legible and mounted securely.

F. Securement:

 All loads shall be secured as required by Virginia Code §46.2-1155 and 1156.

- G. Vehicle's headlights and any other steady burning exterior lights shall be turned on while moving an overweight or oversized permitted vehicle. Hazard/4-way flashers shall not be used when vehicular speed exceeds 35 mph. This exclusion in the State Code does not preclude the requirement for amber warning lights if so required.

Part VI

Emergency Services and National Defense Moves

SECTION 16 - Emergency Moves

Notification for emergency moves will be made to the Permits Office and will be carefully reviewed. All emergency move requests shall be made through the Newport News Permits Office at (757) 926- 8611, or after normal office hours through the Newport News Police Department dispatch at (757) 247-2500. After receiving verbal approval for an emergency move, an application for a permit shall be made within one (1) business day after the move.

SECTION 17 - National Defense Moves

The U.S. Department of Defense's Military Traffic Command shall be the sole certifying agency during peacetime for all movements made by an agency declared essential to the national defense. Contact with the City Permits Office for permitting and routing is required. During a national emergency, movements essential to national defense would be far greater in scope, and those not under direct control of one of the military departments or Department of Defense agencies would be certified by the appropriate emergency transportation authority.

PART VII

Exemption to Permit Requirements, No Cost Permits and Permits Covered Under State Permits

SECTION 18 - Equipment or Items Exempt from Having a City of Newport News Permit

The following categories of vehicles are exempt under Virginia Code § 46.2-1102 from size limitations and do not require a permit.

1. Farm machinery, agriculture multipurpose drying units, but amber warning lights required.
2. Firefighting equipment.

SECTION 19 - Equipment or Items Covered under State Permit

A current, no cost State Hauling Permit will be valid within the City of Newport News for the following as defined in the Virginia Code:

Part VIII
Responsibilities

SECTION 20 - Compliance with Federal, State and Local Laws

The acceptance of a permit by the applicant is his agreement that the vehicle or object can and will be moved strictly in compliance with the terms set forth in the permit; that the operator and vehicle are properly licensed; that the information given by him and as shown on the permit is correct; and that all legal requirements concerning operational authority imposed by the Motor Vehicle Laws of Virginia, Department of Motor Vehicles, City of Newport News, or the Federal Highway Administration / US Department of Transportation have been complied with by the applicant. No person, owner, representative, agent, employee, designee or affiliate of the permittee shall encourage, force or knowingly allow anyone to violate the regulations or restrictions set forth in the permit and regulations. For additional information, contact the permitting authority (See Part I - Section 3.B).

SECTION 21 - Injury or damage

By acceptance of the permit, the permittee. assumes all responsibility for an injury to persons or damage to public or private property caused directly or indirectly by the transportation of vehicles and loads under permit. Furthermore, the permittee agrees to hold the Commonwealth of Virginia, Department of Transportation, the City of Newport News and any other state or local agency and their employees harmless from all suits, claims, damages or proceedings of any kind, as a direct or indirect result of the transportation of the permitted vehicle.

Part IX

Denial; Revocation; Refusal
to Renew; Appeal;
Invalidation

SECTION 22 - Denial; revocation; refusal to renew; appeal; invalidation

A hauling permit may be revoked upon findings that the permittee violated the terms of the permit, which shall incorporate by reference these rules, as well as state and local laws and ordinances regulating the operation of overweight or oversized vehicles. Repeated violations may result in a permanent denial of the right to use the city roadways for transportation of overweight and oversized vehicle configurations. A permit may also be revoked for misrepresentation of the information on the application, fraudulently obtaining a permit, alteration of a permit, or unauthorized use of a permit.

Permits will be invalid if the vehicle or vehicle combination is found by a law-enforcement officer to be operating in violation of permit conditions regarding route, time of movement, licensing, number of axles or any special conditions contained within the permit.

SECTION 23 - Violations and Penalties

- A. The Newport News Police Department, supported by the Department of Engineering's Permits Office, is responsible for the enforcement of over-dimensional/overweight vehicle regulations. Failure to acquire a permit and/or citations that result in a conviction shall be considered a violation.

The owner, operator or person charged with a violation of any weight limit or charged with a violation of the weight limitations of any hauling permit issued by the City of Newport News shall be subject to a civil penalty of liquidated damage assessments as outlined by Virginia Code §46.2 – 1135, as incorporated by City Code §26-8.

Upon issuance of a citation, the owner, operator, or person charged with the violation shall EITHER make full payment as assessed on the citation within 21 days after the citation date to the Department of Motor Vehicles OR deliver written notice to the Department of Motor Vehicles of intent to contest the charge in court as a civil case within 21 days after the citation date. - B. The acceptance of a permit by the applicant is his/her agreement that:
1. The vehicle or objects can and will be moved strictly in compliance with the terms and guidelines set forth in the permit and the Moving and Hauling Regulations;

2. The operator and the vehicle are properly licensed;
 3. That the information given by the applicant and shown on the permit is correct;
 4. All legal requirements concerning operational authority imposed by motor vehicle laws of the United States, the State of Virginia and the ordinances of the City of Newport News have been complied with by the applicant; and
 5. All Federal Motor Carrier Safety Regulations have been complied with.
- C. Permits will be declared null and void if the vehicle or vehicle combination is found by a law enforcement officer to be operating in violation of permit conditions regarding:
- 1 Route;
 2. Time and dates of movement;
 - 3 Licensing;
 4. Number of axles;
 5. Any special conditions contained within the permit;
 6. Any portion, part or section that has been altered or if any attempt to alter is apparent;
 7. The permit's use to represent proper authority for carrying a load and/or moving a vehicle which is not specifically indicated on the permit;
 8. The permit's use to represent proper authority for carrying a load and/or moving a vehicle by any company, not specifically named on the permit.
 9. The possession of the permit, which does not have the signature of the owner, operator, or designated agent of the permitted vehicle.
