HOWEVER, IF A MEETING IS CANCELED, REQUESTS FOR REZONINGS, CONDITIONAL USE PERMITS OR SPECIAL EXCEPTIONS WILL BE MOVED TO THE NEXT REGULARLY SCHEDULED MEETING.*

Applications for rezoning, conditional use permits, variances and special exceptions can not be processed if there are delinquent real estate taxes owed to the city against the subject property.
