

ORDINANCE NO. 6785-11

AN ORDINANCE TO AMEND AND REORDAIN CHAPTER 19, SOLID WASTE, LITTER AND RECYCLING, OF THE CODE OF THE CITY OF NEWPORT NEWS, VIRGINIA, ARTICLE IV., RESIDENTIAL SOLID WASTE FEES, SECTION 19-41, RESIDENTIAL SOLID WASTE COLLECTION FEES.

BE IT ORDAINED by the Council of the City of Newport News, Virginia:

1. That Chapter 19, Solid Waste, Litter and Recycling, of the Code of the City of Newport News, Virginia, Article IV., Residential Solid Waste Fees, Section 19-41, Residential solid waste collection fees, be, and the same hereby is, amended and reordained as follows:

CHAPTER 19**SOLID WASTE, LITTER AND RECYCLING****ARTICLE IV. RESIDENTIAL SOLID WASTE FEES****Sec. 19-41. Residential solid waste collection fees.**

(a) Prior to July 1, 2011, residential solid waste fees shall be collected by the city in accordance with the following schedule based upon the size of the authorized container:

- (1) *Standard residential trash containers* - Five dollars and thirty-eight cents (\$5.38) per week per container.
- (2) *Medium residential trash containers* - Four dollars and thirty cents (\$4.30) per week per container.
- (3) *Three hundred (300) gallon or larger containers* - Five dollars and thirty-eight cents (\$5.38) per week per unit times eighty percent (80%) of the number of units.
- (4) *One medium and one standard residential trash container* - Nine dollars and sixty-eight cents (\$9.68) per week for both containers.
- (5) *Two standard residential trash containers* - Ten dollars and seventy-six cents (\$10.76) per week for both containers.

(b) On and after July 1, 2011, residential solid waste fees shall be collected by the city in accordance with the following schedule based upon the size of the authorized container:

- (1) *Standard residential trash containers* - Five dollars and sixty-five cents (\$5.65) per week per container.
- (2) *Medium residential trash containers* - Four dollars and fifty-two cents (\$4.52) per week per container.
- (3) *Three hundred (300) gallon or larger containers* - Five dollars and sixty-five cents (\$5.65) per week per unit times eighty (80) percent of the number of units.
- (4) *One medium and one standard residential trash container* - Ten dollars and seventeen cents (\$10.17) for both containers.
- (5) *Two standard residential trash containers* - Eleven dollars and thirty cents (\$11.30) per week for both containers.

(c) There shall be no additional charge for the collection of authorized recycling containers.

(d) There shall be no additional charge for collection of bulk waste properly placed at curbside that does not exceed six (6) cubic yards.

(e) There shall be no additional charge for collection of residential vegetative waste properly placed at curbside that does not exceed six (6) cubic yards.

2. That this ordinance shall be in effect on and after July 1, 2011.
