**ALL VOTERS MUST HAVE A PHOTO ID ON ELECTION DAY!**

The Constitution of Virginia requires that you be registered in the precinct in which you live in order to be qualified to vote.

In order to be eligible to vote in the **November 5, 2019 General Election**, you must register no later than **5:00pm on Monday, October 15, 2019**. For the convenience of eligible citizens, voter registration applications are available at the places listed below:

**Tuesday, October 29, 2019** is the last day to request an absentee ballot **by mail**. **Saturday, November 2, 2019** is the last day for this election on which qualified applicants may **vote absentee ballots in person**. **City Hall and Fountain Plaza II** will be open from **9:00am – 5:00pm**.
